The Inland Revenue has agreed that OASIS membership fees and donations may be treated for tax purposes in accordance with the Gift Aid rules. This means that for every pound we receive from a tax paying member we can now reclaim 25p. This will make a considerable difference to our finances over the years.

In order to comply with Inland Revenue rules, we must be in receipt of the attached form, completed and signed. Please read the notes below carefully; you must be a taxpayer and if this changes at any time, you must notify the Treasurer. Only the taxpayer within the family membership can sign the form.

We are able to backdate this benefit to April 2000. As you know we did not collect renewal fees during that financial year but any new membership fees received will be eligible.

We hope that everyone eligible will take the time to send in the form with their renewal forms. It is after all the children left in the many homes around the world that will benefit from any additional income we receive.

Inland Revenue Notes

1. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that the charity reclaims on your donations in the tax year (currently 25p for each £1 you give).
2. You can cancel this declaration at any time by notifying the charity.
3. If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that the charity reclaims, currently £3.75, you must cancel your declaration.
4. If you pay tax at the higher rate you can claim further tax relief in your Self-Assessment tax return.
5. Please notify the charity if you change your name or address.
